

## STEPPIN' OUT® T-SHIRT DESIGN COMPETITION \$500 Prize

## Downtown Blacksburg, Inc. is sponsoring a design competition for the 44th Steppin' Out® 2025 T-Shirt

Steppin' Out® is the premiere festival in the New River Valley and is managed and produced by Downtown Blacksburg, Inc. (DBI) Held on the first weekend in August of each year, this year's event is August 1st & 2nd, 2025 and will mark the 44th annual celebration. The activities include live music on four stages, arts & crafts booths, downtown merchant booths, children's art & craft activities, the Draper Mile running race, and food for purchase provided by local restaurants and vendors.

Profits from T-shirt sales are used to fund this event and to support the general mission of DBI to provide leadership, marketing, and opportunities for businesses located in the downtown commercial district.

Designs should reflect the character of *Steppin' Out*® in addition to downtown Blacksburg in general.

Designs will be judged by the DBI Festival Committee. The winning artist will be profiled through advertising/news articles, in store windows where t-shirts are sold prior to the festival, and at Steppin' Out®.

Requirements: Maximum of 6 colors on shirt back and 2 colors for pocket logo. The shirt back design must incorporate the words "Downtown Blacksburg" and the date August 1 & 2, 2025. The pocket logo should include the words "44th Steppin' Out".

## **DEADLINES:**

Concept sketches are due by February 15, 2025.

Once chosen, the winning designer must submit design files in eps or vector format no later than March 1, 2025.
